

PUBG M Dew Challenge 2020 Tournament Rules

Format

- First 2048 teams to confirm their slot by paying the registration fee and confirm their slot at discord.
- Each team consists of 4 or 5 (1 Substitute)
- TPP Mode
- Map : Erangel, Miramar, Sanhok, Vikendi (Sanhok and Vikendi starts to be played at Qualifier Finals)

Qualification

- Basic information of players.
- Players from any PMPLs teams cannot join the Qualifier.
- Only mobile devices are used (no tablets or emulators).

Registration

- Registration opens 14 December 2020 - 8 January 2021
- Team captain or Team representative will handle registration for the rest of the teams
- Slot confirmation is based on first come first serve by completing the Slot Confirmation email
- Team information cannot be changed after registration.

Tournament information

This tournament will be divided into 3 Stages

- Stage 1 - Qualifier (22 December 2020 until 15 January 2021)
- Stage 2
 - Semifinals Phase 1 (19 January until 26 January 2021)
 - Semifinals Phase 2 (27 & 28 January 2021)
- Stage 3 - Grand Finals (29 January 2021)

Stage 1 - Qualifier

- 2,048 teams will be divided into 128 groups (each group will have 16 teams)
- 16 Days
- 8 Groups/Day
- Each Group will play 2 Maps (Erangel TPP, Miramar TPP)
- Only the top 4 teams from each group will proceed to the Semifinals (4 x 128 = 512 teams)

Stage 2: Semi Finals Phase 1

- 512 teams will be divided into 32 groups (Each group will have 16 teams)
- 6 Days
- 6 Groups/Day for 5 days and 2 Groups/Day for 1 day
- 4 Maps (Erangel TPP, Miramar TPP, Sanhok TPP, Vikendi TPP)
- Only the top 2 teams from each group will proceed to Semi Finals Phase 2 (2 x 32 = 64 teams)

Stage 2: Semi Finals Phase 2

- 64 teams will be divided into 4 groups (Each group will have 16 teams)
- 2 Days
- 2 Groups/Day
- 8 Maps (Erangel TPP, Miramar TPP, Sanhok TPP, Vikendi TPP)
- Only the top 4 teams from each group will proceed to Grand Finals (4 x 4 = 16 teams)

Stage 3 - Grand Finals

- 16 Teams
- 1 Group
- 8 Maps (Erangel TPP, Miramar TPP, Sanhok TPP, Vikendi TPP, Erangel TPP, Miramar TPP, Sanhok TPP, Vikendi TPP)

Point System

Scoring for each Tournament Game will be based on each Team's final kill count and in-game placement as set forth below.

Tiebreaker

In the case that two or more different teams in a group have the same amount of points and the rankings are unable to be determined, the tiebreaker procedures will be run in the particular order:

1. Team with higher total kill
2. Team with higher final round total point
3. Team with higher rank in the final round

The Prizes are as follow:

1. The Championship team will be awarded a total cash prize of RM 100,000 and invited to participate in a 1 week bootcamp training with the Geek Fam PUBG Mobile teams. The Championship team will be required to participate in video and photo shoots during the bootcamp period to produce video content and thereafter participate in the video production process.
2. The 2nd place to 10th place teams will also receive cash prizes subject to the table above and will be required to participate in video and photo shoots as required by Dew Challenge once the event concludes

Technical Problem

Any technical issues occurring regarding the player's own equipment/internet will be solely on the player's responsibility to solve. Organisers will only be assisting for issues that came from organiser/third party issue, such as:

- Discord is down.
- PUBG Mobile server goes under maintenance.

Rematch Conditions

The following are the cases where a rematch can be established due to a problem.

The Organizer may order a rematch if the following occurs:

- Situation where the referee thinks that there is an unfair gaming environment.
- Situation where the referee decides that the game can't be continued normally due to a technical difficulty. Exceptions include a player's personal mistake and carelessness.
- Situation where the game stops or freezes on the loading screen not being able to move.
- When there are missing players before the match starts.
- The match starts and the plane flies, but two or more Players are not on board the plane.
- Situation where two or more players may not be able to play the game because of an unintentional in-game bug within the first minute of the first circle.
- Situation where 10% of the players can't connect to the game when the match starts (Online).

Rematch conditions are valid for the first 5 minutes of the game. Videos of bug experienced by the players need to be submitted to the marshal within the 5 minutes for the remake request.

Against the rules

These list of actions below are against the rule

- Cheating is prohibited. Any modification of the PUBG MOBILE game client by any player, Team or other Team Member is prohibited. The use of any kind of cheating device or cheat program, or any similar cheating method such as signaling devices, hand signals, talcum powder and cell phone screen protectors, etc. shall be deemed cheating.
- Players can submit a report if there's any team cheating with solid evidence, which is a video proof.
- Intentionally using any in-game bug to seek an advantage is exploiting and is prohibited. Exploiting includes acts such as making use of any game function that, at Tournament Organizer's sole determination, is not functioning as intended and violates the design purpose of PUBG MOBILE.

Important Information

- Programs that help reduce the ping are not recommended due to the system will automatically ban.
- Unless expressly stated otherwise, offenses and infringements of these Competition Rules are punishable, whether or not they were committed intentionally. Attempts to commit such offenses or infringements are also punishable. The Tournament Organizer's determination as to the appropriate disciplinary action will be final and binding.

PUBG Mobile Dew Challenge 2020 Terms & Conditions

1. The "PUBG Mobile Dew Challenge 2020"(Tournament) is being organized by Geek Events. ("Organizer").
2. The Tournament is open to all Malaysia residents who are Thirteen (13) years of age at the time of entry and having a valid PUBG Mobile User ID ('Participant') excluding a) Permanent and/or contract employees of the Organizer (including its subsidiaries and related companies), including but not exclusive to their respective immediate family members, meaning parents, spouses, children and siblings; b. Representatives and/or agents (including advertising agents and contest management agents) of the Organizer, including but not exclusive to their respective immediate family members, meaning parents, spouses, children and siblings.
3. It is the responsibility of the Participant to ensure that they are legally entitled to participate in the Tournament.
4. The Tournament is valid on special label packs of 400 ml PET bottles of 'Mountain Dew Regular' playing this offer (Product/s). Purchase of the Product is mandatory. Product also available without this Tournament.
5. This Tournament is valid from December 14, 2020 to 30 January, 2021 inclusive within Malaysia and Singapore.
6. The Organizers may in their absolute discretion curtail or extend the Tournament Period, as it deems necessary without any liability whatsoever and without any obligation of giving prior notice; and no communication in this regard will be entertained.

11. Participants can participate in the Tournament once every week as he/she wants during the Tournament Period.
12. The decision of the Organizers with regard to validity of the participation shall be final and no claim or communication would be entertained by the Organizers in this respect.
13. Organizers shall not be liable for any complaints regarding the usage/validity/content/defects relating to the Prize. PUBG Corporation continues to be liable for the usage, validity, content and quality, service, defects etc. of the Prize.
14. 19. Except as specifically set out herein and to the maximum extent permitted by law, all conditions, warranties and representations expressed or implied by law are hereby excluded. To the fullest extent permitted by law, we hereby exclude and shall not have any liability to any Participant or winner in connection with or arising out of this Tournament howsoever caused, including for any costs, expenses, forfeited Prize, damages and other liabilities.
20. Organizers assume no liability or responsibility for (i) any errors, omissions or inaccuracies of content or submissions, (ii) personal injury or property damage of any nature resulting from Participant's access to, Participant's exposure to or Participant's participation in the Tournament (iii) Any unauthorized access to or use of our secure servers and/or any and all personal information and/or financial information that may be contained therein (iv) Any deletion of data or interruption or discontinuance of transmission to or from or through the Tournament.

Organizers shall not be responsible for inability of the Participant to access or play the game on App at its optimum functionality, in case this is caused due to slow internet speed, or due to Participant using a device which does not meet the technical specifications required for hosting the App.

22. Organizers shall not be responsible for any loss, injury, death or any other liability arising out of the Tournament or due to participation by any person in the Tournament.
23. Organizers shall not be liable for any loss or damage due to Act of God, Governmental actions, other force majeure circumstances and shall not be liable to pay any amount as compensation or otherwise for any such loss.
